# **Provider impact report**

## 1. Ambition and strategy

Wigan and Leigh College's ambition and strategy as detailed in the 2019-20 access and participation plan:

This access and participation plan seeks to build the College's reputation and experience to ensure that students from a widening participation background continue to have access to a high quality, diverse curriculum offer which reflects the needs of both students and the labour market, whilst providing value for money to students and enhanced outreach and support.

• To develop a vibrant learning experience and community in the University Centre for all staff and students. This will include implementing the HE transition strategy and developing course enhancements.

• To improve the quality of the student experience improving the outcomes for our students.
